

# MSAD #1 MLTI TAKE-HOME

## PRESQUE ISLE HIGH SCHOOL PARTICIPATION AGREEMENT

MSAD #1 is pleased to offer a program in conjunction with the State of Maine Learning Technology Initiative to provide Presque Isle High School students the use of electronic devices. In order to protect the integrity of the program and insure its success, we must insist that students and their parents take responsibility for the condition and appropriate use of the device. Accordingly, students and parents are required to acknowledge the following conditions and terms in order to participate.

First and foremost, the students and their families are expected to handle and utilize the device with due care. The devices are only to leave the school premises pursuant to the guidelines instituted by MSAD #1, and all rules and recommendations are to be fully complied with. Please recognize that these units are your responsibility while the student is using them.

MSAD #1 will offer an optional laptop/iPad protection plan. The plan has a fee of \$25.00 a year. This fee covers accidental damage (limit 1 per year), ordinary and normal wear and malfunction, and maintenance of the electronic device. THIS COVERAGE WILL NOT INCLUDE WILLFUL, INTENTIONAL OR MALICIOUS DAMAGE OR USE OF THESE DEVICES. ANY SUCH MISUSE OR DAMAGE WILL BE THE FINANCIAL RESPONSIBILITY OF THE STUDENT AND PARENT(S).

There will be an additional \$100 fee for any damages, not covered by Apple, when the district is required to send the device back to the manufacturer for repairs that cannot be performed by MSAD #1 technology staff. This additional fee is to be paid by the student or parent at the time of repair/replacement.

At the discretion of the student's parent or guardian, MSAD #1 shall permit all high school students to take devices home throughout the school year. Furthermore, students in good standing will be permitted to take devices home during summer break. iPads will need to be inspected and inventoried prior to summer take home. In the event the device is not returned, inspected or inventoried as required, the student and parent(s) will be liable for the cost of replacing the device, currently \$700.00. These devices are the property of the State of Maine, and are registered to MSAD #1.

The MLTI Device Take Home Guidelines and Procedures, attached hereto, shall be strictly followed by all students and parents participating in this program. Your signature below acknowledges that you have received those guidelines and this agreement, and further that you understand and agree to follow them.

Again, we are very pleased to be able to offer this beneficial program to our students. Your care in following these guidelines will help insure the success and continuation of the program in future years.
